1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in *Development Business*, Issue Number 737 of October 01, 2008.
2. The Government of India has received a grant from Global Environment Facility [GEF]/ International Bank for Reconstruction and Development and intends to apply part of the proceeds of this grant to payments under the contract for Technical Consultancy **Traffic Safety Audit of BRT and NMT Corridors in Raipur and Naya Raipur under India-SUTP-Naya Raipur**, under SUTP Naya Raipur. The Technical Consultant shall be procured by Naya Raipur Development Authority (NRDA), Raipur, Chhattisgarh.
3. NRDA is a Special Area Development Authority constituted under C.G. Town & Country Planning Act, 1973; by the Government of Chhattisgarh for planning and development of a green field city "Naya Raipur" for its capital functions.
4. Project: Under the GEF India Sustainable Urban Transport Program (SUTP) being implemented by the Ministry of Urban Development (MoUD), Government of India, Naya Raipur Development Authority (NRDA), has availed funds to provide urban transport infrastructure and services between Raipur and Naya Raipur and within Naya Raipur. These investments are expected to promote environmentally sustainable public transport, which are efficient, reliable and user-friendly. NRDA intends to contract Bus Service between Raipur – Naya Raipur and within Naya Raipur with the following objectives
 - i. To provide safe, reliable, rapid and comfortable mode of public transport system
 - ii. To optimize public transport travel times,
 - iii. To ensure efficient fleet management and, performance
5. Three bus corridors have been selected for bus services -
 - a. Corridor-I BRTS Lite services (25km) from Raipur Railway Station to Capitol Complex in Naya Raipur , Via NH-53
 - b. Corridor-III BRTS Lite services (18km) Within Naya Raipur
 - c. Corridor-II City bus services (35km), from Kabir Nagar to Capitol Complex in Naya Raipur Via NH-30

6. Broad Scope of Services for the Consultant would include:

- (1)** To identify potential conflict points, spots where risk is accentuated and recommend appropriate interventions supported by drawings and costs. The study shall be carried out for the following areas of Raipur and Naya Raipur.
 - a. City Arterial Roads(100m/60m) and Intra- Sector Roads (24m/18m/12m) with in Naya Raipur
 - b. All the intersections in Naya Raipur.
 - c. Near all the BRTS Bus Shelter and Pick-up Points (should cover the pedestrian access ways and street crossings within a 200 – 250 m distance).
- (2)** Safety requirements shall apply to the current phase which is under implementation and also in respect to the projects to be implemented in the near future with emphasis on identification of factors associated with accidents, consideration of the same, and recommendation for the appropriate remedial measures.
- (3)** Safety Requirements shall include measures associated with traffic management and regulation such as road signs, pavement marking, traffic control devices, roadside furniture, highway design elements, illumination, warnings, enforcement and emergency response.
- (4)** To identify and suggest adequate locations and designs for traffic signage such as Mandatory/Regulatory Signs, Cautionary/Warning Signs and Informatory/Guide Signs as per IRC within Naya Raipur.

7. Duration of Consultancy

- i. Duration for this consultancy is expected to be 4 months.
- 8.** The Naya Raipur Development Authority now invites qualified, experienced and eligible technical consultants to indicate their interest in providing the Services with all supporting documents, substantiating qualification to perform the services, experience in similar assignments and skills among staff for carrying out study. Interested consultants must provide information indicating that they are qualified to perform the Services (brochures, description of similar assignments, experience in similar conditions, CVs showing availability of appropriate skills among staff, etc.).
- 9.** Consultants may associate to enhance their qualifications. The “Association” may take the form of a joint venture (with joint or several liability) or of a sub consultancy.
- 10.** A consultant will be selected in accordance with the procedures based on the Consultant’s Qualifications (CQS) set out in the Guidelines for Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers May, 2004, revised October 2006, revised May 2010 and Revised July 2014
