Tenderer should have carried out One similar work of value not Less than 230.00 Lakhs or Two similar work each of value Not Less than 140.00 lakhs in the Last 5 years with effect from 1st April 2006. [similar work shall mean System integration in DESIGNING, SUPPLYING, INSTALLATION, TESTING AND COMMISSIONING OF AUDIO VISUAL SYSTEM in any Central/State Government/PSU/or a reputed private sector co such as Reliance/Tata/Wipro/Infosys/ Cognizant etc. (copy of Purchase order/work order, satisfactory Completion Certificate issued by competent authority, payment receipts and TDS duly attested/certified by CA or Notarized shall be submitted by the bidder)

MODE OF SELECTION

The tenderer shall be QUALIFIED IN FOLLOWING STAGES-

Stage: I - Technical-bid and its design, schematic-drawings & proposed deviation

Evaluation Committee (EC) of NRDA will **evaluate the minimum eligibility criteria along with the submitted Design, schematic-drawings & proposed deviation**. On the basis of the evaluation and review, if the committee feels a need for revision in some of the specification or design parameter, the same shall be notified to all those adjudged qualified and they will be given an option to revise their financial bid. The decision of the EC in this regard shall be final and binding.

Stage: II - Price-bid

The price bid in respect of the bidder qualified in stage I shall only be opened.

The tenderer with the lowest financial offer shall be selected.
